The average stay at Agape is between 2-6 months depending on each individual's personal situation. Agape residents are expected to work toward goals like finding a job, paying debts or earning a GED. Our office connects women with local agencies and services, working with them to find housing and childcare. Throughout the process, our staff offers encouragement and support.
